Standard Terms, Conditions & Motor Sport Regulations

Payment Terms

Payment is due strictly 30 days from date of invoice. Payment for a booking made within 8 weeks of the event is due in full at the time the booking is made. CPOP reserves the right to cancel bookings, with the loss of deposit or cancellation fees charged, as detailed below, where the payment terms are not met. All invoices unpaid after their respective due date for payment shall carry interest on the amounts outstanding from time to time at a rate of 2% above the current base rate of Barclays Bank Plc.

Refunds

Please note that all deposits are strictly non-refundable. In the event of a reduction in guest numbers or cancellation, no refunds can be made.

Cancellations

The client may only terminate an order by notice in writing to CPOP Ltd. CPOP shall be entitled to charge:

- The total value of the package ordered, verbally or in writing, if the cancellations is received less than 8 working weeks prior to the commencement of the event.
- 50% of the total value of the package ordered in the cancellation is received more than 8 but less than 12 weeks before.
- The loss of the deposit or a 10% cancellation fee, which ever is the greater amount for any cancellation to a confirmed booking received greater than 12 weeks from an event.

Confirmation of booking

A receipted VAT invoice will be issued with the booking confirmation and the balance invoice, where appropriate, will be sent in good time for payment to be effected by the final due date, being 8 weeks in advance of the event. All admission badges, tickets and car park labels will be sent on receipt of final payment only. Souvenir programmes will be in the facility on the day.

Lost badges and tickets

Badges and tickets will be despatched by special delivery and will have to be signed for to confirm receipt. CPOP Ltd cannot accept responsibility for any badges, tickets or car park labels once they had left the CPOP office. Payment must be made for any replacement badges, tickets or car parking labels in transit. It is highly recommended that you despatch your tickets to your guest by special delivery.

Dress

Smart casual wear is normal in the hospitality facility. Please bear in mind that it is an outdoor event located on parkland.

Advertising

Hospitality facility users may not affix or display or permit to be affixed or displayed anything whatsoever outside the facility, or visible form outside the facility.

Abandonment

In case of the event being abandoned after 9.00am on the Thursday immediately preceding it, no refunds will be made. Where the event is cancelled before that date, a refund will be made subject to necessary charges for catering.

Revisions

Whilst every effort will be made to present the packages as described, CPOP Ltd reserves the right to alter where necessary the details of the packages whilst maintaining the value of any packages so affected.

Motor Sport Regulations
